Subject: Filling up of posts by Cantonment Boards-reg.

In response to questionnaire of SCoD, DGDE has inter-alia stated vide their note dated 03.03.2023 as under:-

"....presently, the Cantonment Division of the DGDE is facing a major challenge and constraints relating to financial condition of 54 deficit Cantonment Boards. These Cantonment Boards do not have adequate funds to carry out essential repair, maintenance and development works in the Cantonment Areas leading to resentment among the public at large".

2. In light of above, it has been decided that DGDE shall hold the current process of recruitment by Cantonment Boards in abeyance till the financial situation improves so that establishment costs do not impede provisioning of basic essential services and development works by the Cantonment Boards. DGDE may evaluate the necessity for filling up the posts on case to case basis and release such vacancies based on requirement and financial situation of the Boards, after giving due consideration to alternative solutions like job sharing reassigning existing staff to address any short term staffing issues etc.
